

GRAB-A-GRAND TERMS AND CONDITIONS OF ENTRY

1. The competition “Promoter” is You Play We Play Limited (Registered in England and Wales Company Number 5834186), with correspondence address: PO Box 13413, Birmingham, B25 9BW, United Kingdom.
2. The “Player” is an individual who wishes to take part in the free competition.
3. The free competition is open to persons aged 16 or over. You must be 16 or over to play or claim a prize. Proof of identity may be required.
4. No purchase is necessary to enter.
5. To enter the free competition simply complete your details in the Name and Email Address fields, read and accept these terms and conditions by ticking the box and choose five different numbers from 1-50.
6. The Player will then receive a confirmation email from the Promoter (“the Confirmation”). If you do not receive the Confirmation you must contact [Dedicated Member Support](#) immediately.
7. The Confirmation will also provide the date of the EuroMillions draw (“Valid Date”) which the Player should refer to in order to check whether the Player has matching numbers. Details of winning numbers for each EuroMillions draw are published on the Promoter’s website www.youplayweplay.com.
8. EVERY POSSIBLE COMBINATION of the two Lucky Stars is covered.
